

Details for Implementation of Academic Exchange Program
under the Memorandum of Understanding on the Scientific Cooperation
between
The Comisión Nacional de Investigación Científica y Tecnológica
(CONICYT), Chile
and
The Japan Society for the Promotion of Science (JSPS), Japan

Based on the provision of Article IV of the Memorandum of Understanding on the Scientific Cooperation between the Comisión Nacional de Investigación Científica y Tecnológica (CONICYT) and the Japan Society for the Promotion of Science (JSPS), the Details for Implementation of Academic Exchange Program have been agreed upon as follows:

I. Procedure

1. The sending side will nominate candidates for exchange at least 3 months in advance of the proposed date of visit.
2. In making the nominations, the sending side will provide the receiving side with the following data on each candidate:
 - Curriculum vitae and list of publications
 - Name and affiliation of collaborating scientists in receiving country including relevant correspondence
 - Detailed plan of visit
3. The receiving side will send its acceptance notice to the sending side at least 2 months in advance of the proposed starting date of the visit.
4. The sending side will communicate the arrival details, including the exact date of arrival, the flight number, and the airport of disembarkation, at least 2 weeks in advance.
5. The receiving side will arrange an initial contact at the airport of disembarkation, if necessary.

II. Financial Support

1. CONICYT will provide financial support as follows:
 - A. For Japanese Scientists
Both short-term and long-term visiting scientists will be provided with a US\$50/day allowance to cover meals, transportation and incidentals. Said

amount is sufficient to cover these expenses.

Housing expenses, including utilities, shall be provided by the host institution.

B. For Chilean Scientists

Round trip airfare, economy class, via the most direct route from the embarkation to the disembarkation point.

2. JSPS will provide financial support as follows:

A. For Chilean Scientists

1) Short-term visitors

a) Maintenance allowance to cover the cost of accommodations, meals, commutation and incidentals: ¥18,000/day

b) Supplementary allowances to cover domestic travel for research: ¥100,000

c) Cost of medical and accident insurance
(Any pre-existing illness will not be covered)

2) Long-term visitors

a) Maintenance allowance to cover the cost of meals, commutation and incidentals:

¥300,000/month for senior scientists (6 years or more after receipt of Ph.D.)

¥270,000/month for junior scientists

b) Supplementary allowances to cover domestic travel for research: ¥100,000

c) Research expenses: ¥40,000

d) Housing subsidy: the actual amount of rent minus ¥10,000 up to a maximum of ¥100,000 per month

e) Cost of medical and accident insurance
(Any pre-existing illness will not be covered)

B. For Japanese Scientists

International transportation between the two countries.

III. Other Matters

1. The annual quota for visiting scientists will be counted according to the fiscal year of the sending side: that is from January 1 to December 31 for CONICYT and from April 1 to March 31 of the following year for JSPS.

2. Any remaining quota for scientist exchange in one fiscal year will not be carried over to the next fiscal year.

3. The visiting scientists are required to conduct research in those universities or research institutes which are authorized by hosting side; namely, those which come under the supervision of CONICYT for visitors to Chile and those which come under the supervision of the Japanese Ministry of Education, Science, Sports and Culture for visitors to Japan.

4. The proposed visitor is required to have made prior contact and arrangements regarding the visit with his/her prospective host scientist or institution in the receiving country.

5. Visiting scientists are required to possess sufficient speaking/writing skills in either English or the language of the receiving country.

6. Amendments to the Details for Implementation may be proposed by either CONICYT or JSPS. Such amendments will become effective when CONICYT and JSPS have mutually agreed upon them.

The present Details for Implementation remain valid during the effective period of the Memorandum of Understanding on the Scientific Cooperation between CONICYT and JSPS.


